Our families. Our friends. Our shared values. Our survival.

COVID-19 has inspired a deeper appreciation for our common humanity; and the growing outcry about systemic racism has compounded the pain of the pandemic and brought millions together to heal and move forward stronger as a country. Both crises have magnified the glaring disparities in access to health, racial justice, and economic security experienced by people throughout our country – issues that particularly plague people of color, and that nonprofits work hard to address.

Cause Effective has always recognized that nonprofit organizations are essential - it's why we were founded nearly 40 years ago. Today, as we partner with organizations impacted by COVID-19, we see again and again the critical role they play in the lives of millions of people. And not just for those who directly rely on them. Nonprofits are one of the social structures that enable us to care for each other. It's where we find community. Where we seek hope. And where we join together for solutions, as we partner to ensure the most marginalized among us are not overlooked.

These times have shaken many nonprofits to their core. But we've lived through crises in the past, and we've learned that organizations can overcome challenging times by doubling down on their core

mission and centering those who are most impacted by inequities.

In the aftermaths of 9/11, the 2008 financial crash, and Hurricane Sandy, Cause Effective worked with organizations not just to meet each challenge, but to use it to be better prepared for the future. These organizations were resilient because they understood how staying true to their central mission enabled them to make tough decisions in crucial moments. As newly-inspired staff and board leaders strategize around how to deliver programs based on altered circumstances, transformative change results.

After 9/11, Cause Effective counseled Human Rights Watch as they mobilized against the anti-Arab messaging so pervasive at the time. Human Rights Watch connected countering this hate speak to its vital mission, launching a campaign that reframed the issues and successfully fundraised to address it. **During the Financial Crash of 2008,** Cause Effective guided Union Settlement to develop a long-term fundraising strategy to deal with the new economic reality. Our partnership helped Union Settlement overcome internal fundraising roadblocks and expand its resources. By 2012, Union Settlement's annual gala raised 40% more than it had in the past.

When Hurricane Sandy hit the East Coast, GOLES (Good Old Lower East Side) swung into action as a unified team to support the area's stranded seniors. The long-term relationship between GOLES and Cause Effective, building trust and defining board-staff roles, enabled the group to pivot to meet the moment, resulting in tremendous community pride and elevating the organization's standing citywide.

Today, facing the impact of these turbulent times, an organization's ability to emerge from this will take a solid partnership between the staff and board of directors with a laser focus on its essential mission.

Cause Effective views its work in 2019 through the prism of building #nonprofitresiliency – the preparatory work necessary so that, in the words of one of our clients, "my board was ready to have the hard conversations that have been necessary." Fundraising pivots, alternative program scenarios, difficult staffing decisions – boards and staffs have had to partner closely in the past few months to steer their nonprofits through very tricky economic times. The groundwork for that was laid well in advance.

This is the time to meet the moment and build for the future. We will always face challenges in our society. We encourage you to take the time now to ensure that leadership within your organization – and the organizations you care about – is positioned to navigate what lies ahead, and to use this moment to create a more resilient organization going forward.

BUILD NYC: READY FOR THE FUTURE

Problem

BUILD NYC approached Cause Effective for help energizing its board of directors to become more effective fundraisers, including how to empower new board leaders to become active fundraising thought partners for staff.

Solution

Cause Effective recognized that BUILD NYC needed a fundraising strategic plan – that board and staff needed a framework for how to grow the agency's fundraising that everyone could sign onto. Restructuring the board development committee to provide a peer-to-peer voice, and offering full board training in fundraising, gave board members access to a wealth of resources that both inspired them and held them accountable.

Approach

"Cause Effective was always accessible in helping us have a clearer vision of where we had to go. You opened our board's eyes and gave them a new perspective about fundraising," reflects Director of Philanthropy Pamela Minetti.

Regional Executive Director Chymeka Olfonse agrees: "In my conversations with Cause Effective and my role as executive director, I recognized the importance of having the board step up. As we pivot now in this time of uncertainty, thanks to Cause Effective's support we're well-suited to have a strong fundraising plan and even stronger board engaged in the process."

Results

Cause Effective helped BUILD NYC raise more money by providing board and staff with the tools and coaching to achieve these higher goals. With Cause Effective's guidance, BUILD NYC was able to meet and even exceed its \$1.35 million fundraising goal.

But Cause Effective also "helped our board to become better board members," remarked Pamela, which is paying off now that COVID-19 is forcing realignment of the agency's programming due to events beyond their control.

Chymeka adds: "We prepare our students for the unknown – and now we're equipped to do the same for ourselves as an organization."



Development leaders play a central role in their organization's growth, sustainability and ability to achieve impact. These professionals enter into the nonprofit sector with enthusiasm and see the development profession as a way to make a difference in the world and build a career. Yet for even the most seasoned fundraisers – it can be a highly stressful job.

For development directors of color, the challenges to stay in the field are compounded because their ability to do the job is often questioned and they encounter microaggressions, tokenism and racism. Cause Effective has partnered with hundreds of nonprofit fundraisers of color in our nearly 40-year history. But throughout the years we have seen time and time again, fundraisers of color leave the sector dismayed, never to return.

Cause Effective has made a commitment to partner with organizations and institutions to address the lack of support for fundraisers of color. We understood the need to bring greater attention to the issue and to provide solutions to address the growing gap of people of color in leadership positions within the nonprofit sector.

In the summer of 2019, Cause Effective released a report: Money, Power and Race: The Lived Experiences of Fundraisers of Color. This report examined the barriers to success of professionals of color in fundraising. Cause Effective read dozens of articles and reports, and spoke with over 200 fundraising professionals, executive directors, funders, recruiters and others to gain a nuanced understanding of how the dynamics of money, power and race intersect in the philanthropic field. The findings of our research reflected participants' experience that development professionals of color need to have the awareness, tools and support to navigate the intersectional dynamics of power, race and class that are endemic to fundraising.

As a next step in the evolution of our commitment, we decided to play an active role in supporting a pipeline of development professionals of color. In Fall 2019, we launched the Cause Effective Fellows Program: Advancing Leaders of Color in Fundraising, a cohort of 15 senior development professionals who participated in a seven-month curriculum that included workshops, panel conversations and coaching from senior advisors.

The Asian American Federation (AAF) works with a network of 70 Asian-led and serving community-based agencies to raise the influence and well-being of the pan-Asian American community through health & human services, education, economic development, civic participation, and social justice.

Cause Effective is proud to have partnered with AAF for the past five years in several ways: as a governance and fundraising trainer for the Federation's member agencies; as a consultant for individual nonprofits experiencing roadblocks in fundraising strategy and board-staff relations; directly as fundraising and governance counsel for the Federation itself; and as a mentor and coach to the Federation's executive director as she arew from a hesitant first-time executive director to a powerhouse CEO able to rally the community to counter the anti-Asian sentiment provoked through the rise of the Coronavirus outbreak.

AAF's members are mostly small and operate with limited resources; the community has experienced high executive director turnover. Cause Effective has provided guidance and

tools to help new executive directors focus their energies, prioritize effectively, and strengthen their working dynamics with their boards of directors. We've offered resources to help leaders feel more confident in their fundraising and encouraged them to form a network amongst their peers to gain support.

Cause Effective's executive director, Judy Levine worked closely with Jo-Ann as she grew into the executive director role. One of Jo-Ann's most profound takeaways has been learning to see the board of directors as *"your most powerful partner."* Once you put in the work to build a trust relationship, the board is your greatest champion, she's realized, and the sounding board she's needed to deal with tough times like the pandemic.

> As the Federation looks towards the future, Jo-Ann believes this is a time that leaders of nonprofit organizations should embrace the uncomfortable. The work the Federation did with Cause Effective has pushed her to contemplate questions like: "What does it mean to lead during this time, in the middle of a pandemic?" She is grateful for the partnership with Cause Effective for helping the Federation and its member agencies to have more tools in their

wheelhouse, so they can come out on the other side of COVID stronger with renewed purpose to advocate for their community.




